1. represents US\$ 1,000,000 principal amount of bonds outstanding out of the Company's US\$180,000,000 2 per cent coupon convertible bonds. These bonds are convertible at a price of Rs. 656.20/- per equity share. The increase in capital on account of these bonds would depend on the number of bonds that are converted by the bondholders.

2. represents US\$ 1,400,000 principal amount of bonds outstanding out of the Company's US\$98,700,000 5 per cent convertible unsecured bonds. These bonds are convertible at a price of Rs. 80.31/- per equity share. The increase in capital on account of these bonds would depend on the number of bonds that are converted by the bondholders.

3. represents US\$ 91,400,000 principal amount of bonds outstanding out of the Company's U.S.\$127,721,000 5.70 per cent secured convertible bonds. These bonds are convertible at a price of Rs. 22.79/- per equity share. The increase in capital on account of these bonds would depend on the number of bonds that are converted by the bondholders.
